HICKS SHELDON

The Albany and Susquehanna Railroad
Company, being authorized and organized by the
State Legislature to construct a railroad from
Albany to Binghamton, built the railroad in sections.

The first section extended from Albany to Central Bridge and its engineers, seeking a favorable grade, found the desired route passed through the upper part of the Normanskill Valley which provided an improved means of transportation for this vicinity. This first section was constructed during the years 1861 to 1863 inclusive and in the latter year, transportation was established between the above mentioned points.

To best serve the needs of Quaker Street, a site was chosen for a station and other necessary facilities. A station and a freight house were erected on the east side of the highway crossing, between certain tracks existing at that time. This point was given the name Quaker Street Station.

The Delaware and Hudson Canal Company was organized and then expanded by buying or leasing railroads from Rouses Point, New York to Wilkes-Barre, Pennsylvania and extending the canal from Honesdale, Pennsylvania to Rondout, New York. The Albany & Susquehanna Railroad became the Susquehanna division of the Delaware and Hudson Canal Company.

YOUR CORNER OF HISTORY: HICKS SHELDON (CONTINUED FROM PAGE 3)

Later, the canal properties were sold to Samuel Coykendall, who dropped the word "canal" from the corporation title. The Schenectady and Duanesburg Railroad, built from Delanson to Schenectady connected with and became part of, the Susquehanna division of the Delaware and Hudson Railroad at Delanson. The formation of this junction brought increased activities to this point, making it necessary for more men to be employed.





Homes were built for the railroad workers, and several businesses opened up around them, including a coal business owned and operated by Mr. Hicks Sheldon. Mr. Hicks Sheldon was well known throughout the county and enjoyed the respect and esteem of all. In 1870, Mr. Sheldon purchased a large quantity of property along the Albany and Susquehanna Railroad. At that time, the section of Railroad was known as Quaker Street Depot and only contained a small station and freight house (photo on page 3). Due to his activity and enterprise, the small village expanded to several stores and places of business that ultimately led to the construction of many beautiful residential homes many, of which still stand today. 

Please keep in mind that if you are spotted not cleaning up behind your pet, you are in violation of your community's guidelines and could be cited and fined as such.

All dogs in the Village of Delanson must be licensed and confined to the owner's property unless properly restrained by collar and leash. To prevent property damage and possible harm to other pets and residents, dogs running at large are prohibited by Village Law. This measure may also keep your pets from being hit by a train or vehicle or worse carried away by a wild animal. Fishers, bears and fox have all been spotted in the area. WATER PLANT INFORMATION SESSION MONDAY MARCH 10. 2025

Dear Residents:

Greetings! The Village Board would like to take this opportunity to update you regarding the status of the Village water system. As you are likely aware, the Village has been working with our Engineers since 2017 to scope and implement improvements to the Villages drinking water infrastructure. These improvements are not only intended to improve water service for the end-users, but to also address State and Federal mandates that have been placed on the Village water system.

Please recall that in 2017, the Village received an Administrative Order from the US Environmental Protection Agency and New York State Department of Health Department for violation of quality standards for certain constituents that are present above the allowable levels in our drinking water. You have received notices in the past regarding these violations and the presence of Trihalomethanes and Haloacetic Acids in our drinking water that are commonly referred to as "Disinfection By-Products". The Village Board has worked diligently for the last seven years to secure grants and other subsidized financing to offset the costs of capital improvements necessary to comply with the State and Federal mandates.

The Village recently applied for and was awarded a grant from the NYSDOH to make the necessary improvements to the Village's drinking water infrastructure. Although we have received a very favorable grant equivalent to 60% of the total anticipated capital project cost, the remaining debt service will need to be absorbed by the water system end-users. Currently, the proposed capital project debt service at the conclusion of the project is anticipated to increase the quarterly water rate by approximately \$130 per quarter.

As water system customers ourselves, we do not take this rate increase lightly, and it is our intent to continue to work to reduce the anticipated capital project costs. That said, the Village will ultimately be left with some form of debt for the proposed capital project, and we are bound by the USEPA and NYSDOH to move forward with the proposed project to comply with the State and Federal mandates.

We would like to offer residents the opportunity to learn about the proposed capital project, learn how your water rates will be impacted, and understand the value of completing the proposed upgrades to our water system infrastructure. To assist with this effort, the Village Board and our Engineers will be holding a public information session at the Firehouse on March 10th at 6:30 pm to present the proposed project and answer any questions you may have. Additional meetings may be scheduled if needed. Our regular board meeting may be delayed until the conclusion of this public meeting session, but not beyond 8:00pm.

We look forward to seeing you and answering any questions you may have.
