B. TREASURER/CLERK:

The bank balances are as follows as of December 31, 2024:

The water billing software has been brought to current, rebuilding the 2024-2025 data and accounts. Water bills went out on the 1^{st} .

The bill received from Verizon this month for the Water Treatment Plant phone has doubled. Clerk/Treasurer O'Connor called to inquire – it looks like the plan the Village was on has expired and is no longer available. We are now on the basic plan, which looks to be about \$55.00 per month. They have submitted a billing inquiry for me to see if we can get this reduced at all.

Our copier has been serviced and a part replaced, but still has marks on the documents. Will need to call Centurion back to have them come back out.

C. DEPUTY CLERK: Report received along with records destruction.

Trustee O'Connor makes a motion to approve the Records Destruction file 2025-01. Trustee Grenier seconds.

D. WATER DEPARTMENT:

Water Commissioner Iveson had to cancel a meeting last week with Lamont Engineering as he was feeling under the weather.

Joe Coppolo came to the plant to look at the turbidity meter, but isn't able to find parts. He purchased a circuit board on Ebay and wants to see if that will work. Water Commissioner Iveson is using a raw water turbidity meter currently. If the circuit board doesn't work, Water Commissioner Iveson will have to make an emergency purchase on a new one.

Water Commissioner Iveson and Assistant Water Commissioner Pigliavento were doing a filter bed cleaning and smelled a strong odor of chlorine. They found a chlorine line had burst. They were able to fix it after filter bed cleaning. And the pump is now online that he has been working to get running for some months.

Water Commissioner Iveson also will be following up with DA Collins regarding moving ahead with the culvert project on 395.
