4. Peter Brodie – Creation of Town Ambulance District

Local taxpayer bill will show exactly what percentage goes to the ambulance service versus being lumped into the town tax. This will be extremely beneficial in that it will be transparent what is actually spent on ambulance services versus being lumped in with town costs of other items (new truck, etc.).

If the Village passes the resolution, it will be sent over to the Town that will then put it out for a referendum.

Tanker is still out of service. The insurance is going to cover a new pump that is a new pump, but not the casting (outside of the pump) because the original is obsolete. Casing estimate will be about \$2000 - \$5000. Should know more next week.

There is a craft fair on 7^{th} of December; also on that day will be the Toys for Tots train. The train will be coming between 9:30 - 10:00 am.

Fire Protection Contract – on November 14th, there is a public hearing regarding the Town of Duanesburg contracts. The dollar amount they are giving the Village of Delanson is \$87870 for Fire Protection. The Village and Fire Department met with Supervisor Wenzel and requested a budget of \$135,000 due to increasing costs of equipment and repairs. Additionally, 1st Assistant Chief Fink has done the research and has found parcels in Fire Protection 3 District that are not being billed correctly or being distributed directly to the Village, to the amount of \$15,000, meaning that the Village has been shorted this amount each year for numerous years.

Water Commissioner Iveson is bringing it to a test site to see if the sand they delivered was correct. Discussion regarding the sand, the history of ordering and specifications used.

The hydrant flushing will have to be cancelled this month due to the low levels of water.
